# NOTES FROM THE EXECUTIVE DIRECTOR

Our group is very new but already gaining momentum engaging in educational and advocacy activities regarding end-of-life choices to help people legally achieve their wishes for a peaceful and dignified death.

#### ON A NATIONAL BOARD

The Death with Dignity National Center has been instrumental in providing logistic and strategic guidance to our group. It was a great honor to join their Board of Directors, and I am excited to be kept up to date on current legislative activities throughout the U.S.

It's important to bring this discussion to Ohio simply because many people have never heard of aid in dying laws. With California's End of Life Option Act being implemented on June 9th, residents of the most populous state in the nation will now have this choice and more and more people will become aware of it.

#### Nonprofit Status

We've become a 501(c)(3) nonprofit organization and, in addition to all of the progress we've made so far, we are looking forward to launching community outreach events in order to engage community, medical and political groups in discussion with the aim of ultimately getting legislation passed based on Death with Dignity laws.

#### **New Opportunities**

I have already had the opportunity to talk with bioethicists at The Cleveland Clinic, University Hospitals, and the MetroHealth System. This has led to speaking opportunities in undergraduate and graduate courses at CWRU as well as an upcoming Cleveland Clinic Bioethics Grand Rounds speaking engagement. I'm looking forward to sharing my personal experience with physicians attending the Mayo Clinic's national Annual Oncology Review Course in July as well as local hospice groups. I was honored to sit on a panel at the national Healthcare Journalists' Conference in April and discuss "what is a good death" alongside journalists, hospice and bioethics experts.

#### LEGISLATIVE OUTREACH

Another important opportunity came when Lakewood resident, Judith Allen, organized a meeting with her State Representative Nickie Antonio (D–District 13) and other interested community members and invited me to present my family's experience along with facts and data about death with dignity laws.

Moving forward, we need to meet with more legislators, both in person and in events like Lobby Days in Columbus.

# WHAT CAN I DO NOW?

#### TALK WITH YOUR FAMILY MEMBERS

This is important if you hope one day to have options for your own dying. Since there is no legislation in Ohio with regard to medical aid in dying, this is currently not an option.

Be sure to have advanced directives in place and consider designating a healthcare proxy in case you are unable to make decisions. Are you aware that advanced directives are not legally binding? Because of this it is critical that your family or support systems are aware of your wishes. You cannot rely on written directives alone.


